# **Annual Report** 2015











On Behalf of the Canadian Environmental Grantmakers' Network (CEGN) board and staff, we are pleased to provide this brief report on CEGN's recent work and the new strategic direction that we are embarking on. But before going any further, we would like to recognize the tremendous work of our members. CEGN's diverse membership is drawn from private, public, and community foundations, as well as corporate and government environmental funding programs. Tackling a range of environmental issues at different geographic scales and with varied strategies, our members share a common goal of securing a more sustainable future for Canada. At CEGN, our mission is to strengthen philanthropy's impact in support of this shared goal.

Catalyzing collaboration has been a key focus for our work since the network's inception. In 2015, three CEGN funders groups: Low-Carbon, Water, and Sustainable Cities, made important strides toward better understanding the landscape for each issue, and pursued opportunities for shared learning and collaborative engagement. Key factors driving the evolution of these funder groups are: committed CEGN members who co-chair the group; a growing appetite for collaboration on the part of many members; and the belief that collaboration can lead to greater impact.

Using a landscape assessment prepared by Dunsky Energy Consulting, our Low-Carbon Funders Group is focused on strengthening the role of philanthropy in advancing a low-carbon future for Canada. Our Water Funders Group engaged in a collective impact workshop in support of the Our Living Waters platform and with a major grant from RBC, the group is developing protocols for the shared measurement of activities designed to enhance freshwater protection in Canada. And our Sustainable Cities Funders are embarking on a webinar series looking at urban sustainability issues from the national, regional, and

Building and sharing skills and knowledge remains a second core strategy for CEGN. This work takes many forms, including webinars which draw participants from across Canada and beyond. Our 2015 webinar topics included: the public policy role of charities with Imagine Canada; the move towards transparent and open data with Philanthropic Foundations of Canada; and a report by Julie Gelfand, Canada's Commissioner of the Environment and Sustainable Development. We continue to work with the Sustainability Network to deliver webinars to a larger audience when topics are of interest to both funders and the

The CEGN environmental grants database has developed into an important knowledge-building tool for the network. Providing information regarding the extent and focus of environmental grantmaking across a range of issues and geographies, the database can help funders see their own place in the spectrum of environmental philanthropy and identify gaps and overlap in funding. For example, through the database research, we have become acutely aware of the relatively small amounts of environmental funding being directed to Atlantic Canada, Saskatchewan, and Northern Canada. CEGN's most recent analysis of environmental grants data is currently being finalized and will be based on an analysis of more than \$120 million in grants issued by 98 funders in 2014. We look forward to leading a conversation with members about the picture of environmental grantmaking that emerges from this update.

Our annual conference remains a core event for the network, connecting members, supporting collaboration, and increasing our capacity and skills as funders. In 2015, the conference was held in Toronto with the theme "Economic Opportunities and Environmental Imperatives: Building Canada's New Economy." It was one of our largest conferences yet, with informative sessions and excellent networking opportunities, bringing funders together for learning, discussion, and fun. We look forward to continuing the conversation with members at our 2016 conference at Tigh-Na-Mara in June.

On June 1st of 2015, during the closing ceremonies for the Truth and Reconciliation Commission (TRC), the Declaration of Action from the Philanthropic Community was presented by a number of philanthropic organizations, as well as funder affinity groups. CEGN is a signatory of the Declaration and was in Ottawa for the presentation. Signatories pledge, among other things, to work towards reconciliation and the implementation of the spirit, intent, and content of the TRC's recommendations, and to ensure that the philanthropic community is engaged in the work of reconciliation. Honouring this commitment is a priority

With support from Innoweave, the CEGN Board and staff undertook an intensive process in 2015 to develop a theory of change for the organization. Through this process we have landed on a vision of CEGN as "a vibrant network of funders advancing a sustainable Canada." Our strategies to support this vision are:
