## Nurturing relationships and catalyzing collaboration among our members

Our first regional gathering of the year brought together young leaders and funders for Youth and Funders Powering Environmental Action in Vancouver for the chance to discuss the strategic value of engaging youth to advance environmental wins, wise practices for funding and engaging youth, and to build connections with other BC-based funders and youth leaders. We paired this event with a blog featuring an interview with the Lawson Foundation about their perspectives on empowering young environmental leaders through their Youth Action and the Environment program.

We convened in Ottawa for an in-person federal government and philanthropic funding collaboration brainstorming session involving EFC members and senior leaders in the federal public service who oversee large, related funding envelopes to proactively identify broad areas for potential coordination of philanthropic and government granting activities over the long term.

We continued our partnership with The Circle on Philanthropy for a two-day event in Vancouver with a learning agenda co-developed by thirteen Indigenous leaders from all three coasts — Upwelling & Truth Telling. This in-person and virtual event brought together senior leadership from all of the major conservation organizations to learn from a two-year research effort between The Circle and EFC to share honest and frank Indigenous experiences working with conservation ENGOs.

Our funder collaboratives – the Oceans Collaborative and Low Carbon Funders Group – each increased investments in 2024 to support Indigenous-led oceans conservation and strong federal climate policy respectively. Our newest addition, Building Power for Climate and Nature, burst onto the scene with the development of a directory of over 700 organizations working in this space, guest presentations from organizations like Supermajority, Climate Emergency Unit and Mosaic Momentum, and numerous strategy sessions with 34 respected advisors from across the country to help us shape this funder collaborative and pooled fund.

We continued to facilitate our Funder Interest Groups (FIGs) — Conservation Finance, Indigenous Protected and Conserved Areas, Trust-based Philanthropy, and Let's Talk Climate. Chaired by EFC members, our FIGs met regularly to discuss knowledge sharing, funding opportunities and collaboration, and welcomed guest speakers, including The Transition Accelerator, Federation of Canadian Municipalities, Ivey Business School, Dark Matter Labs, Carolinian Canada Coalition, and RAD Network.

Earlier in the year, EFC began hosting a series of funder-sharing sessions on Indigenous-led legal strategies, with a recognition of how powerful and high-impact this work can be, including in our shifting environmental and political landscape.



# Mobilizing knowledge, building skills and advancing thought leadership on environmental funding opportunities to support our members

We did a happy dance with the launch of our <u>new website</u>, with a bold new design, improved user navigation experience, greater inclusion of French translation, and an expanded resource library!

Project Finance for Permanence was the topic of our blog post and a collaboration with The Sitka Foundation and Gordon and Betty Moore Foundation, discussing their experiences and perspectives on the exciting Project Finance for Permanence initiatives underway across Canada.

We commissioned a report and hosted a webinar that shared the results of an examination of the state of funder opportunities to advance environmental action in Atlantic Canada, outlining current gaps and opportunities in the philanthropic landscape for environmental action and key opportunities and success stories that will provide funders with clear pathways for giving in the region.

Regenerative agriculture is increasingly recognized as a priority for environmental funders and our Speaker Series webinar, Transforming Agriculture from a Climate and Biodiversity Problem to a Solution in Canada, brought together distinguished leaders in this field to guide us in exploring these critical questions and inspire collective action.

A timely topic with the recent changes in CRA guidance opening a new pathway for funders to support 'non-qualified donees' (NQDs) through direct grants, our What It's Like on the Frontline Supporting NQDs Speaker Series webinar welcomed Toronto Foundation and Laidlaw Foundation to share their firsthand experiences funding NDQs.

We expanded our reach with the participation of our Executive Director in several speaking engagements with the Canadian Association of Gift Planners (CAGP), Philanthropic Foundations of Canada (PFC), a gathering of community foundations exploring climate action in Waterloo and New Power Labs.

# Promoting transparency through open data to build greater accountability to all stakeholders in the environmental funding ecosystem

Our highly anticipated Charitable & Grants Data for the Environment reports were unveiled and provide an environmental funding snapshot of EFC members. Estimating Funding to Canadian Environmental Operating Charities 2000 to 2021 is an analysis of CRA data to understand how large a slice of the charitable pie goes to the environmental sector. The second report, 2022 Environmental Grants Data Landscape Snapshot, offers a snapshot of 2022 grants data and the environmental work being funded by our members.
